

Company A is proposing a rights issue to finance a new investment. Its current debt to equity ratio is 10%. Which TWO of the following statements are true?

- B. Company A's current low gearing ratio may require a rights issue rather than a debt issue to finance the new project.
- C. The issue price has to be at least 20% below the pre-rights share price.

Answer: D,E

Explanation:

C). True - If the new project has a positive NPV, the company's total value increases, so the actual ex-rights price can be higher than the purely mechanical TERP, which ignores project NPV.

E). True - Under Modigliani & Miller with tax, the cost of equity increases with gearing (more debt # more financial risk). A rights issue used to finance a project reduces D/E, so the cost of equity will fall compared with a more highly geared structure.

The others are false:

A). No rule that the issue price must be 20% below the market price.

B). A deep discount encourages take-up but cannot guarantee it.

D). Low gearing would usually allow more debt, not force an equity issue.

Explanation:

Debt becomes more attractive when:

Corporate tax increases # larger tax shield on interest.

Bond yields decrease # lower pre-tax cost of debt.

So the combination that makes a bond issue more attractive is higher tax and lower yields.
