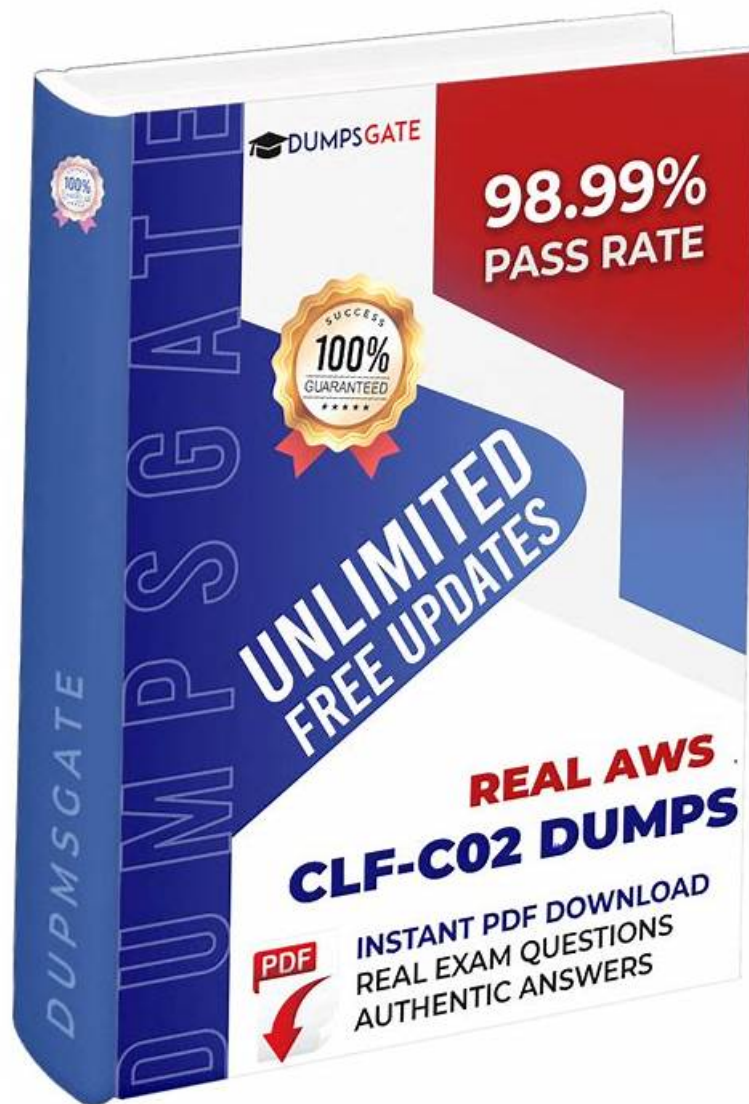

VPC endpoint, virtual private gateway, and AWS Config are not designed to protect a workload from these types of attacks.

It can be used to deploy containerized software, but it does not store source code or update software.
