This can help to optimize costs and performance across the organization.

\* Administrators have the ability to create accounts in any available cloud provider or region using the CREATE ACCOUNT command, which allows specifying the cloud platform and region for the new account<sup>3</sup>. This can help to meet the business needs and compliance requirements of the organization.

Option A is incorrect because administrators cannot change Snowflake account editions on-demand based on need, but rather have to contact Snowflake Support to request an edition change<sup>4</sup>. Option C is incorrect because administrators cannot simplify data movement across all accounts within the organization, but rather have to enable account database replication for both the source and target accounts, and use the ALTER DATABASE ... ENABLE REPLICATION TO ACCOUNTS command to promote a local database to serve as the primary database and enable replication to the target accounts<sup>5</sup>. Option D is incorrect because user administration is not simplified across all accounts within the organization, but rather requires creating and managing users, roles, and privileges for each account separately, unless using a federated authentication method such as SSO or SCIM.
