A decision table is a technique that shows the combinations of conditions and actions for a given scenario. A decision table that is not collapsed contains all possible combinations of conditions and actions, regardless of whether they are valid or not. The conditions for this scenario are:

- * Salary less than €20 000

- * Married

- * Number of children more than two and less than five

The number of cases is equal to the number of possible combinations of these conditions, which is 2
