질문 # 41

What action is required by the consignee to complete the delivery receipt?

정답: C

설명:

Completion of proof-of-delivery relies on verifying that what arrived matches what was shipped and is in acceptable condition. The consignee (receiving facility) performs inventory and condition checks before signing delivery documents. CLT receiving/dispatch content reinforces verifying quantities, item identity, and damage status against the pre-advice (ASN) and shipping documents prior to formal acceptance. Creating a carrier freight bill is the carrier's function; putaway happens after acceptance and documentation. Notifying a supervisor may occur if discrepancies are found, but the core requirement to complete delivery documentation is to perform inventory and inspection, ensuring accurate receipt records for subsequent inventory updates and claims processing if needed.

질문 # 42

Which of the following is typically seen in home centers and warehouses that handle and store materials such as lumber, steel sheets and rods, and other relatively long unusually large items?

- A. push-back racks
- B. drive-in and drive-through racks

정답: D

설명:

Cantilever racks are open-sided storage systems designed for long or bulky items such as lumber, pipes, or steel bars. The CLT "Product Storage Systems" module describes cantilever racks as having arms extending from vertical columns, allowing easy side-loading by forklift. They provide unobstructed front access, making them ideal for materials that vary in length or shape. Drive-in or push-back racks accommodate palletized goods, not elongated materials. Cantilever racks improve space utilization for oversized items and minimize damage by eliminating front uprights. Proper training in load distribution and weight capacity is essential to ensure safe operation. These racks exemplify specialized storage solutions taught in CLT training for managing nonstandard materials.

Which of the following governing bodies is responsible for collecting taxes on imported and exported goods?

정답: C

설명:

The U.S. Customs and Border Protection (CBP) collects tariffs, duties, and taxes on imported goods entering the United States. As CLT 4.0 explains, CBP is part of the Department of Homeland Security and manages both trade enforcement and revenue collection functions. Duties and tariffs are assessed based on the Harmonized Tariff Schedule (HTS), which classifies goods according to their type, value, and country of origin. The WTO and State Department guide policy, but only CBP enforces and collects. Understanding CBP's role helps logistics personnel ensure accurate customs declarations and prevent costly penalties for underpayment or misclassification. Tariff collection supports fair trade and protects domestic industries from unfair competition while funding essential government programs.

Which of the following consists of component inventory used to feed into production or manufacturing lines?

정답: D

설명:

Raw material stock refers to the unprocessed inputs stored for use in manufacturing. The CLT "Inventory Control" standards distinguish among three major categories: raw materials, work-in-progress (WIP), and finished goods. Raw materials are held in inventory to feed production lines, ensuring continuity of manufacturing operations. Effective management prevents production delays while avoiding overstock. CLT emphasizes that raw material inventories must be closely coordinated with procurement and production schedules—often managed through systems like MRP or JIT. Proper labeling, storage, and traceability of raw materials are vital for quality control and compliance with industry regulations. Unlike WIP (partially completed items), raw materials are inputs awaiting transformation into finished goods.

What information would be unnecessary in a packing slip sent with the customer's shipment?

- A. internal stock adjustments
- B. the origination of the shipment
- C. any items placed on backorder
- D. the contents of the shipment

정답: A

설명:

A packing slip accompanies outbound shipments and provides a detailed list of what is included in the shipment, its origin, and any backordered items. According to the CLT "Packaging and Shipment" standards, its purpose is to confirm what was shipped and assist the customer in verifying receipt. Internal stock adjustments, however, are warehouse control data related to inventory accounting and are not relevant or appropriate for inclusion on external documents. Including such internal data could cause confusion or reveal proprietary operational details. The CLT emphasizes clear, customer-facing communication—packing slips should reflect only what directly relates to the customer's order fulfillment, ensuring transparency and professionalism in documentation.
