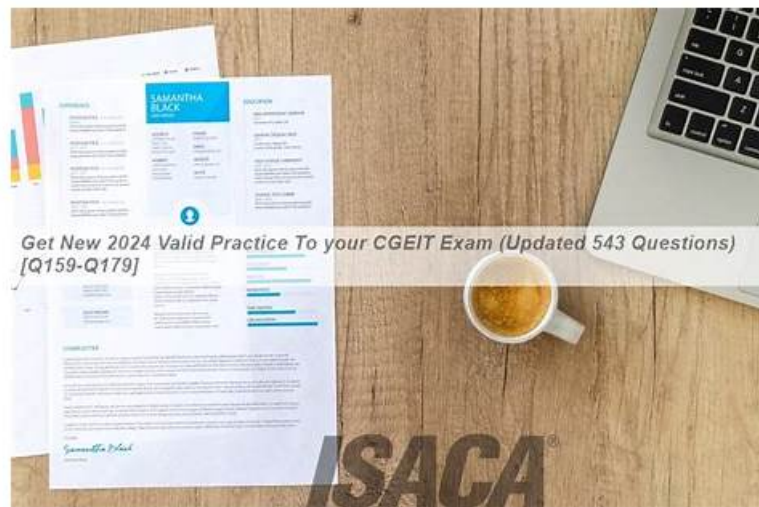

This can help to ensure the successful execution and monitoring of the IT strategic plan, as well as the alignment with the business strategy and expectations⁴.

The other options are not as important as option A. While it is useful to have specific resourcing requirements, frameworks, and implications of the strategy on the procurement process, these are more operational and tactical aspects that can be determined later in the implementation phase. A risk register is a tool that records and tracks the identified risks, their causes, impacts, likelihood, responses, and owners.
