Release notes and change logs are valuable for understanding evolution, migration, and backward compatibility considerations, but they are not typically required to implement the tests for the current API behavior when the current specification is available. They may help explain why something changed or guide test updates over time, yet they are less directly relevant to writing the core automated checks compared with endpoint inputs, auth, and response structure. Therefore, among the options, past release notes/change logs are the least relevant for implementing automated tests on the API.
