Therefore all given statements are incorrect, making D the right answer.

It always has two dimensions: product and version, not customer (A incorrect), and each configuration must have a unique identification to be referenced in change management (B false). Within a specific configuration, chosen versions are fixed; further changes create a new configuration rather than altering the existing one, so C is wrong. A key purpose is to provide a stable basis for reset: the ability to revert to a known configuration if later changes cause problems. Thus, D is correct.
