問題 #18

This proactive, inclusive approach ensures commitment is sustained over time, improving response effectiveness during disruptions.

Resource availability is not the primary reason, and risk assessments are integral to ongoing BCMS maintenance rather than conditional on business plan updates or solution development.

Conducting internal exercises to assess impacts remains essential to understand dependencies and potential vulnerabilities without compromising exercise control.
