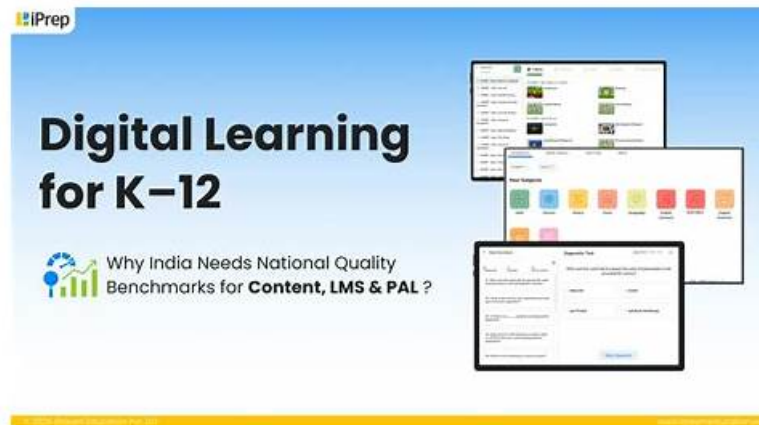

Secondary power supplies must meet minimum performance durations to ensure alarm operation when primary power fails. According to NFPA 72, the system must be able to:

NFPA 72 (2022), Section 10.6.7.2.1.1:

"The secondary power supply shall have sufficient capacity to operate the system under quiescent load for a minimum of 24 hours, followed by 5 minutes of alarm (for emergency voice/alarm communication systems, 15 minutes of alarm), unless otherwise permitted by 10.6.7.2.1.2." However, the default minimum for most systems (non-voice) is:

- * 24 hours in normal (quiescent) mode
- * Followed by 5 minutes of full alarm operation

"Distinct waterflow condition" refers to alarm testing and is not part of the inspection phase.

"A condition where a fire protection or life safety system or portion thereof is out of service." Smoke detector placement issues may be a code violation but not a system impairment. Intelligible audibility is a positive attribute, not a problem.

Correct answer: A. Closed sprinkler valve

NFPA 72 (2022), Section 21.3.3.1:

"Activation of the smoke detector installed at the designated level shall cause all elevators that serve that level to return to an alternate level." But:

"Smoke detector activation in any other elevator lobby shall recall elevators to the designated level." So:

* If smoke is in the ninth-floor lobby, and that lobby is not the designated level # elevator recalls to designated level.

* Therefore, activation of the ninth-floor smoke detector (not the designated level) causes designated level recall.

Correct answer: B. Designated level recall
