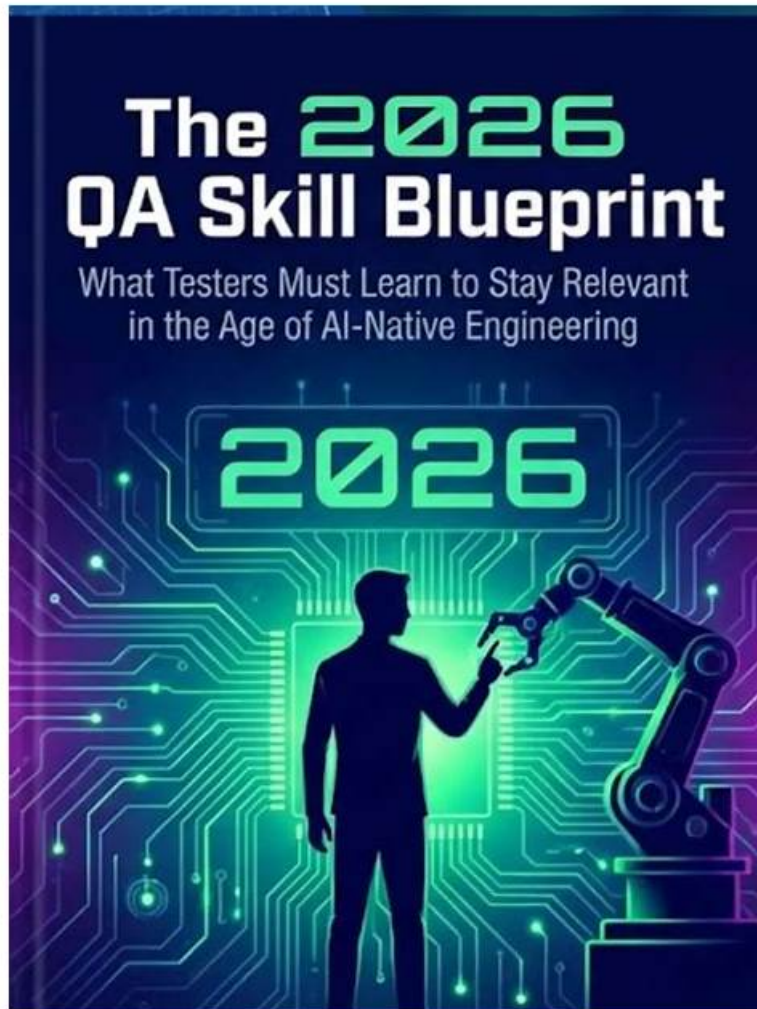

C . Use the without sharing keyword on the class declaration: This runs the class in system context, ignoring sharing rules, which is the opposite of what's needed.
