Airway bill - ANS A bill of lading for air transport that serves as a receipt for the shipper, indicates that the carrier has accepted the goods listed, obligates the carrier to carry the consignment to the airport of destination according to specified conditions.

Advanced ship notice (ASN) - ANS An electronic data interchange (EDI) notification of shipment of product.

Aggregate inventory management - ANS Establishing the overall level (dollar value) of inventory desired and implementing controls to achieve this goal.

Batch pick - ANS A method of picking orders in which order requirements are aggregated by product across orders to reduce movement to and from product locations. The aggregated quantities of each product are then transported to a common area where the individual orders are constructed.

Basic Description - ANS Required description on documentation when shipping or handling hazmats. It must include: the Identification Number; Proper Shipping Name; Hazard Class or Division; and Packing Group.

Bill of lading - ANS A carrier's contract and receipt for goods the carrier agrees to transport from one place to another and to deliver to a designated person. In case of loss, damage, or delay, the bill of lading is the basis for filing freight claims.

Bonding - ANS A system that connects various pieces of conductive equipment together to keep them at the same potential. Static sparking cannot take place between objects that are the same potential.
