Option A (participation rewards) may help but does not guarantee meaningful engagement. Option B (relying solely on community partners) risks over-dependence and may not reach all groups. Option D (survey with extended duration) is a single method and may not address broader engagement needs. TheCPC Study Manual(2024) supports option C, noting, "Effective engagement involves specific plans to include diverse communities and flexibility to adjust methods."
