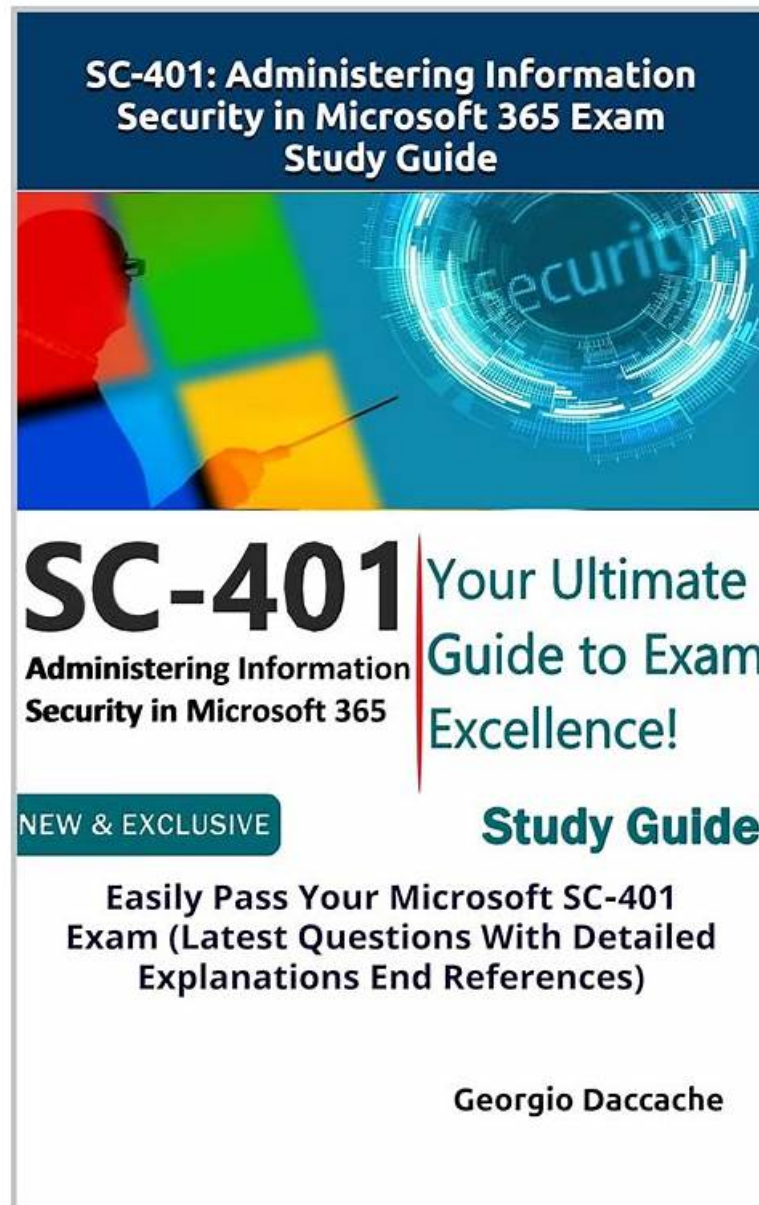

解説:

For Microsoft 365 Copilot to summarize data within a file, the user must have both the EXTRACT and VIEW usage rights on the sensitivity label applied to that file, according to Microsoft Learn.

This ensures that Copilot can access and process the file's content for summarization purposes.

If a file is encrypted using Azure Rights Management without a sensitivity label, the same permissions (EXTRACT and VIEW) are still required for Copilot to function.

Sensitivity labels can be applied to modern Office file types that support protection:

Supported: .docx, .xlsx, .pptx, etc.

Not supported: Legacy formats like .doc or non-Office formats like .txt.

Therefore, only File2.docx and File3.xlsx can have Label1 applied.

Solution: From the Microsoft Defender for Cloud Apps, you mark the application as Unsanctioned.

解説:

You can unsanction a specific risky app by clicking the three dots at the end of the row. Then select Unsanction. Unsanctioning an app doesn't block use, but enables you to more easily monitor its use with the Cloud Discovery filters. You can then notify users of the unsanctioned app and suggest an alternative safe app for their use.

EDM does not store raw data; instead, it requires hashed versions of sensitive data for privacy and security. To upload the hashed data, Microsoft provides the EDM upload agent. This ensures that the data is securely processed and recognized by the EDM service in Microsoft 365.
