This means the communication obligation is not limited to top management (A) or only ISMS staff (B), nor does it stop at employees only (C). Instead, ISO/IEC 27001/27002 mandate a broader scope: all relevant personnel and relevant interested parties must be informed. This ensures both internal stakeholders (employees, contractors, temporary staff) and external interested parties (suppliers, partners, regulators, customers, etc.) receive the right policy communications where applicable.
