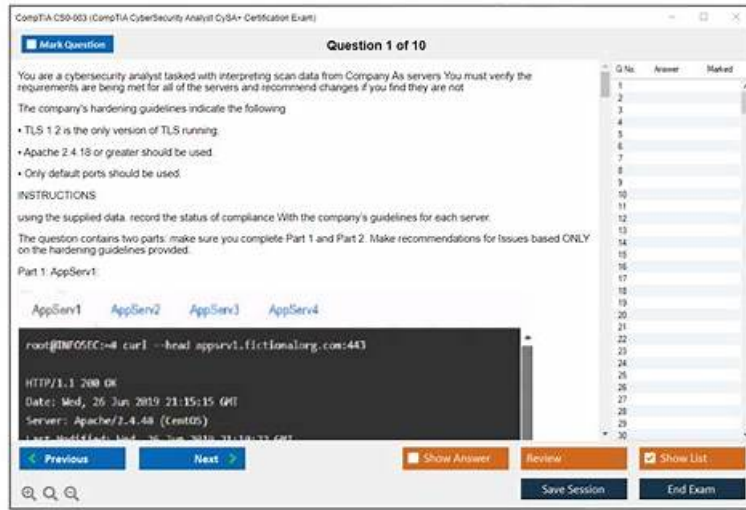

A virtual patch is a rule that blocks or modifies malicious requests or responses at the WAF level, without modifying the application code. These recommendations are effective, efficient, and less disruptive than the other options.
