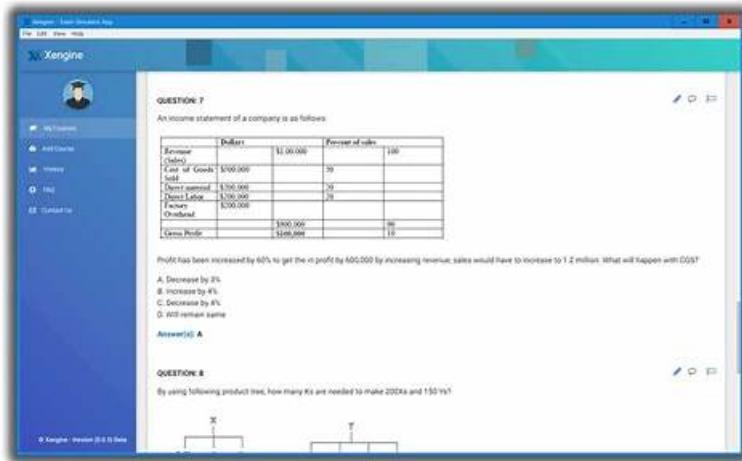

Impossible. Posted invoices cannot revert to draft.

C . Delete Invoice

Posted invoices cannot be deleted.

D . Credit the invoice manually

Does not follow the required cancel-re bill flow; also would not automatically issue corrected invoice.

Therefore A is the only Salesforce-compliant corrective action.
