However, they have notable downsides: people may focus on filling the template rather than thinking deeply about content, and any aspect not explicitly represented by a field in the template tends to be overlooked. This can lead to missing important information. Therefore option D correctly captures a documented disadvantage; C is obviously false because the syllabus explicitly lists cons.
