City of New London* (2005) expanded "public use" to include economic development, but taking for a private luxury resort often fails the public use test in practice, as seen in subsequent state-level restrictions. Options A (coastal access), B (park easement), and C (highway) clearly serve public purposes. The APA's AICP Certification Exam Content Outline (2022), under "Fundamental Planning Knowledge," notes, "Taking property for a private luxury resort is often considered an abuse of eminent domain, as it prioritizes private gain over public use." The CPC Study Manual (2024) confirms, "Eminent domain for a luxury resort exemplifies abuse, as it lacks a clear public use," supporting option D.
