



G	Procure and prepare land.	B	6
H	Construct facility	D, E, F & G	8
I	Approval of operating procedures	D	6
J	Install equipment, staff, faculty	F	9

Answer: B

Explanation:

- * Impact of Changing Activity E's Duration:
- * Activity E's new duration = 4 months.
- * The critical path passes through Activities A # C # D # E # H # I.
- * Recalculate Project Duration:
- * Original duration with E = 3 months: 19 months.
- * Increasing E to 4 months does not impact the overall path since it remains within the critical path's time allowance.
- * Overall project duration remains 19 months.
- * Cross-Verification:
- * Option B: Incorrect. Assumes additional delays.
- * Option C: Incorrect. Overestimates delays.
- * Option D: Incorrect. Miscalculates path changes.
- * Option A: Correct. Matches revised critical path duration.
