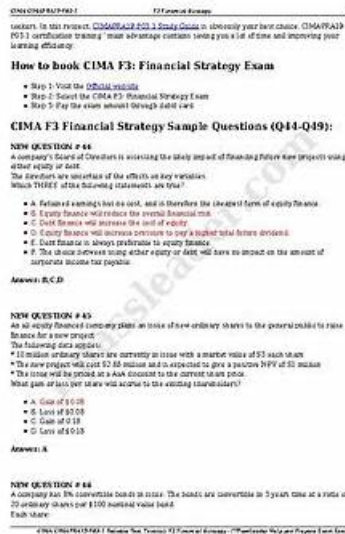

$2/3$ New A shares = $90\text{m} \times (2/3) = 60\text{m}$ Total A shares post-deal = $100\text{m} + 60\text{m} =$

160m Step 2 - Total value post-acquisition with synergies: Combined value = $800 + 450 + 60 = \$1,310\text{m}$ Step 3
