The test is a two-tailed test because the alternative hypothesis contains ( $\neq$ ). If the computed t-value on the lower and higher tails is less than or more than the critical value, respectively,  $H_0$  will be rejected. Additionally, we will also reject  $H_0$  if the p-value is less than the significance level.

## Step 5: Make a decision and interpret the result

The corresponding p-value for the two-tailed test is 0.001226, which is lesser than the significance level of 0.1. The test statistics for value of -3.39977 also falls within the rejection region as the critical value is -1.67155. Therefore, we reject (/do not reject) the null hypothesis and accept the null hypothesis. With 90% confidence, we conclude that the stress levels of both genders are not similar.

## ANOVA - used when there are more than 2 variables for comparison

### Step 1: State the null and alternative hypotheses

Null Hypothesis ( $H_0$ ):  $\mu_1 = \mu_2 = \mu_3 = \mu_4$   
Alternative Hypothesis ( $H_1$ ): Not all the means are equal (claim)

where  $\mu_1$  is the mean stress level among SUSS students  
 $\mu_2$  is the mean stress level among SIM students
