The conflict typology in CPRE distinguishes data, interest, value, relationship and structural conflicts. Value conflicts occur when stakeholders' underlying beliefs, ethics or world-views clash for example, safety vs. profit or privacy vs. data exploitation. These conflicts are deeply rooted, personal and stable over time, so they are hard to resolve by negotiation alone. Relationship conflicts stem from personal animosities or communication problems; interest conflicts concern competing goals; structural conflicts result from power or resource imbalances. Thus, "value" correctly completes the statement.

In CPRE, a requirement is defined as a documented representation of a need, capability or property.

Requirements capture what stakeholders need or expect from a system rather than the system itself. Users are only one class of stakeholders; sponsors, regulators, operators and maintainers also have needs that must be represented. IREB further distinguishes three main kinds of requirements: functional requirements, quality requirements and constraints, not "technical" or "non-functional" as primary categories. Thus, treating a requirement as a documented representation of stakeholder needs is correct and aligned with the foundational definition.
