

The information security controls listed in Annex A are not exhaustive and additional information security controls can be included if needed." Together, these extracts verify that the ISMS implementation is influenced by and scaled to the organization's needs and selected controls, not separated from management processes (A, D) nor mandated to include "all controls" (B).

Options A and B are too narrow, excluding key groups. Option C misrepresents the scope by implying a mutual responsibility but not identifying the individuals covered. The explicit scope includes employees, contractors, and third-party users.

Therefore, the correct answer is D.
