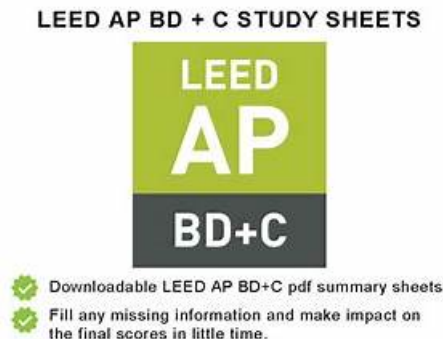

トピック 1	<ul style="list-style-type: none">Energy and Atmosphere: In this topic, LEED Green Associates focuses on building reuse, including historic building renovations. It covers material reuse strategies, enclosure materials, and permanently installed interior components into new designs.
トピック 2	<ul style="list-style-type: none">Project Surroundings and Public Outreach: LEED Green Associates learn about promoting sustainable practices, regional design considerations that incorporate green construction measures, cultural awareness issues related to historic or heritage impacts, and ensuring that sustainability efforts are respectful of local values.

トピック 3	<ul style="list-style-type: none"> • Building Loads: This topic is focused on optimizing building performances through effective load management. It addresses design considerations such as building orientation and glazing selection while clarifying regional factors that influence these decisions.

Explanation

Retail projects must conduct a waste stream audit for the duration of the project in an existing location or make projections based on historical data for similar establishments. Identify the top-five recyclable waste streams while stating the top-four waste streams where both collection and storage space will be provided. This is the requirement for Retail projects under the Materials and Resources Prerequisite, Storage and Collection of Recyclables, according to the LEED v4 BD+C Reference Guide¹. The purpose of this prerequisite is to facilitate the reduction of waste generated by building occupants that is hauled to and disposed of in landfills¹. The prerequisite applies to all LEED BD+C projects, but Retail projects have a different approach than other project types because of their unique waste streams and operational characteristics¹. Retail projects must conduct a waste stream audit for the duration of the project in an existing location or make projections based on historical data for similar establishments. The audit or projection must identify the top-five recyclable waste streams by weight or volume using consistent metrics throughout¹. The waste stream study period must be a minimum of 24 hours¹. Retail projects must also provide dedicated areas that serve the entire building

and are accessible to waste haulers and building occupants for the collection and storage of materials for recycling for at least four of the top-five recyclable waste streams identified by the audit or projection¹. References:

質問 # 229

The owner of a large multi-building property is seeking LEED certification. In determining the LEED project boundaries the LEED AP may include non-contiguous parcels of land if

- A. the parcels are part of a land trust or conservation organization for which the LEED project provides financial support for in the Sustainable Sites Credit, Site Development Credit, Protect or Restore Habitat, Option 2. Financial Support
- **B. the parcels directly support or are associated with normal building operations and are accessible to the project's occupants**
- C. the parcels are used for temporary uses such as parking or staging that is owned and managed by a third party

解説:

In determining the LEED project boundaries, the LEED AP may include non-contiguous parcels of land if the parcels directly support or are associated with normal building operations and are accessible to the project's occupants. This is according to the Minimum Program Requirements (MPRs) for LEED v4.1, which state that non-contiguous parcels of land may be included within the LEED project boundary if they meet these criteria¹. Facilities such as parking lots, bicycle storage, shower/changing facilities, and/or on-site renewable energy that are outside of the LEED project boundary may also be included in certain prerequisites and credits if they directly serve the LEED project and are not double-counted for other LEED projects¹. The other options are not valid reasons to include non-contiguous parcels of land within the LEED project boundary.

Temporary uses such as parking or staging that are owned and managed by a third party do not directly support or are associated with normal building operations of the LEED project¹. Existing public preservation easements or resource protection areas that are directly adjacent to the LEED project boundary are not considered as part of the LEED project boundary, unless they are owned by the project owner or the project team has permission to use them². Land trusts or conservation organizations for which the LEED project provides financial support are not considered as part of the LEED project boundary, unless they are located within the same EPA Level III ecoregion as the project site³.

質問 # 230

A luxury hotel project is in the design phase and is located on a scenic waterfront. It is one point away from attaining LEED Platinum certification. The LEED AP is recommending that the team pursue Innovation Credit, Innovation, Option 3. Additional Strategies. Which of the following credits would be desirable considering the location of the project?

The LEED Platinum certification requires the project to achieve exemplary performance in at least one credit that allows it, as specified in the LEED Reference Guide¹. One of the credits that meets this criterion is the Indoor Environmental Quality Credit, which focuses on providing healthy and comfortable indoor environments for occupants. The credit has two options: Quality Views and Enhanced Commissioning.

Quality Views requires the project to have windows that provide views of natural scenery or water bodies, which can enhance the well-being and satisfaction of occupants. Enhanced Commissioning requires the project to have a comprehensive commissioning plan that ensures all systems are properly installed, tested, and operated before occupancy. Both options can help reduce energy consumption, improve indoor air quality, and create a positive sensory experience for occupants.

質問 # 231

Which of the following projects are eligible for LEED certification?

- A. Prefabricated sandwich panel house
- **B. New office building 900 ft² (83.6 m²)**
- C. Houseboat
- D. Mobile home

正解: B

解説:

To be eligible for LEED certification, a project must:

- * Be a permanent structure on existing land (floating structures like houseboats do not qualify).
- * Have a defined site boundary (mobile homes do not meet this requirement unless they are permanently installed).
- * Have a minimum floor area of 250 square feet (23.2 m²) (so a 900 ft² office qualifies).
- * Prefabricated buildings (Option A) may qualify if they are permanently installed.
- * Houseboats (Option C) and mobile homes (Option D) are not eligible unless permanently located.

The new office building (Option B) meets all LEED requirements and is the correct answer.
