

Step 2 - How group membership changes are logged in Microsoft 365 audit logs Microsoft 365 audit logs record group membership activities in Azure AD. The most relevant activities for a user disappearing from a group are:

Removed member from group - Directly indicates that a user was removed from a group.

Updated group - Logged when group properties or membership rules (for dynamic groups) are modified. If Group1 is a dynamic group, changes to membership rules could have caused User1 to no longer qualify, and this would appear as an Updated group event.

Step 3 - Why not other options

Deleted user / Deleted group: Would mean the entire user or group object was deleted, not just removal.

Changed user password, Reset user password, Set license properties, Changed user license: These are account- related, not group membership-related.

Added member to group: The opposite action.

Step 4 - Microsoft Reference

From Microsoft documentation:

Audit logs include events such as when a member is added or removed from a group, and when group properties or membership rules are updated.

Box 2: The Insider Risk Management role groups determine who can access and contribute to cases:

Admin1 (Insider Risk Management Admins) # Full admin access.

Admin2 (Insider Risk Management Analysts) # Analysts who review cases.

Admin3 (Risk Management Investigators) # Investigators who work on cases.

Admin4 (Insider Risk Management Auditors) # Auditors who oversee cases.

All these roles have default access to insider risk cases in Microsoft Purview, so all four admins are added as contributors.

Step 2 - Sensitive info type elements in Microsoft 365

When creating custom SITs, you define primary and secondary elements:

Primary element # The main pattern or data to detect (the most defining factor).

Secondary element # Supporting evidence that must be found near the primary element to increase confidence.

Available elements:

Regular expression # Used to define patterns such as date + digits (for employee ID).

Keyword list # Used for lists of words/phrases like "Employee", "ID", "Identification".

Functions # Used for built-in validators like credit card checksum, not relevant here.

If a file is encrypted using Azure Rights Management without a sensitivity label, the same permissions (EXTRACT and VIEW) are still required for Copilot to function.
