Operations must be manually upgraded to VCF Operations 9.0 to meet compatibility and prerequisite requirements before VCF Automation can be upgraded or integrated.

Configuration (E): The Orchestrator Active Directory plugin must be configured against the development AD only, ensuring that the development team does not impact the production directory.

Publish Workflow (C): The AD user creation workflow must be published to the VCF Automation catalog using the Content Hub. Actions alone are insufficient; workflows are the full automation logic exposed to end users.

Custom Resource Object (F): To enable developers to create and destroy AD accounts, a Custom Resource object must be created in VCF Automation and mapped to the Orchestrator workflows. This provides lifecycle capabilities (create/destroy) in the self-service catalog.
