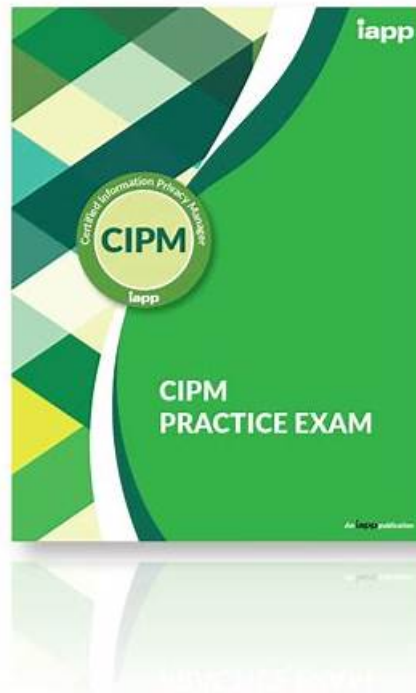

Starting with the data inventory ensures the audit is comprehensive, repeatable, and aligned with accountability obligations under global privacy laws.

Your hiring was precipitated by warnings from regulatory agencies following a series of relatively minor data breaches that could easily have been worse. In fact, you consider your program a model that others in the data storage industry may note in their own program development.
