Option C(select any city in the same climate zone globally) is too broad and inaccurate: "Choosing a city from a different region, even in the same climate zone, may lead to incorrect assumptions about local practices and climate" (EDGE Methodology Report Version 2.0, Section 3.2: Climate Data Inputs).
