Seed content files for a custom trainable classifier should be stored in a SharePoint Online folder (or folders) that is dedicated to holding only that seed content. You'll need to create a separate folder for positive examples and another for negative examples. After placing the files, make note of the full URL of the SharePoint site, library, and folder for each set of content.

Note: How to create a trainable classifier: The following process automates the testing of trainable classifiers and shortens the creation workflow from 12 days to two days. In some cases, the process can take only a few hours.

1. Collect between 50 and 500 seed content items that strongly represent the data you want the classifier to positively identify as being in the category. For a list of supported file types, see Default crawled file name extensions and parsed file types in SharePoint Server.
2. Collect a second set of seed content (from 150 to 1,500 items) that represents data that don't belong in the category.
3. Place the positive and negative seed content in separate SharePoint folders. Each folder must be dedicated to holding only the seed content. Make note of the site, library, and folder URL for each set.
4. Sign in to the Microsoft Purview portal with either Compliance admin or Security admin role access and navigate to Data loss prevention > Data classification > Classifiers.

Step 1 - Review what's configured

Labels: Public, General, Confidential, Internal, External.

Also shown in policy: Confidential/Internal and Confidential/External.

Policy setting: Users must provide justification to remove a label or lower its classification.

Confidential/External # encrypts content when applied.

Step 2 - Analyze each statement

Statement 1: The Internal sensitivity label inherits all the settings from the Confidential label.

Sub-labels (e.g., Confidential/Internal, Confidential/External) do not inherit settings from the parent.

They are independent labels grouped under a parent for organization, but each sub-label must have its own protection settings defined.

Statement 2: Users must provide justification if they change the label of content from Confidential/Internal to Confidential/External.

The policy requires justification only when removing a label or downgrading classification (lowering).

Changing between two sub-labels of the same parent (Confidential/Internal # Confidential/External) is considered a lateral move (not a downgrade).

Statement 3: Content that has the Confidential/External label applied will retain the encryption settings if the sensitivity label is removed from the label policy.

If a label is removed from a published policy, content already labeled retains its protection settings (such as encryption).

The label metadata stays applied to the file/email, even if unpublished.

In Defender for Cloud Apps file policies, Access level is the filter used to detect how a file is exposed (e.g., Public on the internet, External, Internal, Private). Choosing Access level = External matches files that are shared with users outside your organization-exactly the "shared externally" condition.

To target files that carry an MIP/AIP classification such as Internal Only, you use the Sensitivity label file filter. Defender for Cloud Apps ingests Microsoft Purview Information Protection labels and lets you build file policies that trigger when a specific label is applied.

These docs explain that MCAS can filter and govern files by Sensitivity label and apply governance based on labels such as Internal Only, Confidential, etc.

Why not the other options?

Collaborators filters by specific users/domains; it's useful to find files shared with a particular external user but not for the generic "shared externally" condition.

Matched policy is for files already flagged by another policy/DLP engine and does not detect "Internal Only" labeling by itself.
