- * Determine the value, sensitivity, and criticality of information assets⁴
- * Assign ownership and accountability for information assets⁵
- * Establish appropriate security controls and protection measures for information assets⁶
- * Monitor and audit the usage and lifecycle of information assets⁷

The other options are not as important as option D. While it is important to require an information risk assessment, identify systems that are outsourced, and ensure information is classified, these are subsequent steps that depend on the availability and accuracy of the inventory of information assets. Without an inventory of information assets, it would be difficult to perform a risk assessment, identify outsourced systems, or classify information according to its value and sensitivity.
