

The idea behind this technique is to provide users with relevant and timely information about how their data is collected and used by the app, and what choices they have to control their data, at the moment when they are asked to provide or access their data. For example, if the app collects location data from the user's device, it should display a pop-up notice explaining why it needs the location data, how it will use it, and how the user can opt-out or change the settings. This way, the user can make an informed decision about whether to allow or deny the app's access to their data, and understand the consequences of their choice.

The advantage of this technique is that it avoids overwhelming the user with too much information at once, and instead provides concise and contextual information that is easy to understand and act upon. It also increases the user's trust and confidence in the app, as they feel more in control of their data and privacy
