CLT highlights the efficiency, precision, and auditability of barcode-assisted counts as a best practice for modern warehouse operations.

Duties are assessed only when goods leave the zone for domestic consumption, reducing cash-flow and tariff burdens. FTZs support international logistics efficiency by encouraging domestic manufacturing and re-exporting activities. CLT emphasizes FTZ operations as part of global trade compliance and customs procedures, distinguishing them from programs like FAST (a trusted shipper initiative) or CSI (a port security initiative).

Facilities that standardize labeling, bin locations, and sequence picking logically achieve higher accuracy with lower training requirements.
