

AD groups cannot control granting report folder access or custom permission assignment through Identity Connect. These are not supported features of Identity Connect. Report folder access is controlled by the folder sharing settings in Salesforce. Custom permission assignment is controlled by the custom permission settings in Salesforce. The SPs are the websites that host apps and rely on the IdPs for authentication⁵. In this case, Salesforce Org 2, Financial System, and CPQ System are the SPs that receive the SAML assertions or OAuth tokens from the IdPs and grant access to the users.

Option A is incorrect because Financial System is not an IdP, but an SP. It does not authenticate the users, but receives SAML assertions from Pingfederate. Option C is incorrect because Salesforce Org 2 is not an IdP, but an SP. It does not authenticate the users, but receives OAuth tokens from Salesforce Org 1.
