問題 #85

With respect to an insurance contract, what is the best example of consideration?

- A. Martin is returning a shirt he purchased online for \$35 because he found it cheaper elsewhere
- B. Jennifer agrees to sell a \$20,000 painting for \$10,000 to her friend Shania
- C. Yasmin offers to sell her dog for \$500 but Paula refuses
- D. Calvin wants to start a tutoring business and may charge \$40 per hour

答案: B

解題說明:

In contract law, consideration refers to the exchange of something of value between parties. It is a necessary element for forming a legally binding insurance contract. In insurance, the insurer promises to indemnify the insured in exchange for the premium; this exchange constitutes consideration.

Option A is the only scenario demonstrating a clear bargained-for exchange. Jennifer gives up a painting of value, and Shania provides monetary payment. Even though the price is reduced, consideration still exists because each party is giving something of legal value. Option B shows no exchange-only contemplation of future pricing. Option C shows no contract formed, because the offer was not accepted. Option D is a return/refund scenario, not an exchange forming a new contract. Thus, A is the best example of consideration.

問題 #86

When one reinsurer cedes part of its business to another reinsurer, what is the second reinsurer called?

- A. Cessionaire
- B. Alternate Insurer
- C. Retrocessionaire
- D. Primary Insurer

答案: C

解題說明:

In the structure of reinsurance practices explained in Principles and Practice of Insurance, a retrocessionaire is the reinsurer that accepts risk from another reinsurer. This occurs through a process called retrocession, where a reinsurer (the retrocedent) transfers a portion of its assumed risk to another reinsurer to further spread exposure and maintain solvency stability.

The terminology is important:

The primary insurer issues the original policy to the insured.

The reinsurer (cessionaire) accepts risk from the primary insurer.

When that reinsurer then cedes part of the risk again, the receiving party is the retrocessionaire.

Retrocession is essential in risk-management frameworks because it allows reinsurers to diversify exposures and avoid concentration risks from catastrophic events. Therefore, the correct term for the second reinsurer is C. Retrocessionaire.

問題 #87

Rashida claims she told her broker about the swimming pool when binding coverage. The adjuster disputes coverage because the insurer was not informed. What should have been done to prevent this dispute?

- A. Broker should have sent written confirmation to Rashida and the insurer
- B. Broker should have requested a witness during the oral application
- C. Insurer should have contacted Rashida directly before binding coverage
- D. Broker should have requested Rashida send in a signed notice after issuance

答案: A

解題說明:

Whenever coverage is bound orally, the broker must follow up with written confirmation to both: the insured, to confirm the accuracy of information provided, and the insurer, to notify them of all disclosed underwriting details.

This written documentation protects all parties by ensuring the insurer is fully aware of material facts—such as the presence of a swimming pool—and prevents disputes like this one.

Option A is unnecessary and not industry practice.

Option C refers to a notice after issuance, but the dispute occurred at binding, so this is too late.

Option D is incorrect; the insurer does not verify every detail directly with insureds—this is the broker's responsibility.

Thus, the broker should have completed written confirmation, making B the correct answer.

問題 #88

What is stated in the insuring agreements of a policy?

- A. Description of the property covered
- B. Signature clause
- C. Premium
- D. Lienholder

答案: A

問題 #89

How are staff adjusters and independent adjusters similar?

- A. Both work on behalf of, and are paid by, the insurer
- B. Both are licensed only in Quebec and New Brunswick
- C. Neither is allowed to perform an investigation
- D. Neither has any limitation on their authority to settle claims

答案: A

解題說明:

Both staff adjusters and independent adjusters work on behalf of the insurer when handling claims. A staff adjuster is an employee of the insurance company, while an independent adjuster is contracted by an insurer to investigate and adjust claims. Regardless of their employment relationship, both types of adjusters operate under the insurer's authority, follow the insurer's procedures, and act in the insurer's interests when assessing damages, determining coverage, and recommending settlement amounts.

Option A is incorrect because both adjusters do perform investigations. Option C is incorrect—adjusters are licensed in most provinces, not only Quebec and New Brunswick. Option D is incorrect because both staff and independent adjusters have specific limitations on their settlement authority, which depend on the insurer's internal guidelines. Therefore, the similarity that applies universally is B.
