The sensitivity label Label1 assigns permissions (User1 = Co-Author, User2 = Reviewer, User3 = Viewer) and enables Double Key Encryption (DKE). Microsoft 365 Copilot can summarize content only when the service can access the file using the user's permissions. Content protected with Double Key Encryption is not accessible to Microsoft cloud services (including Copilot); as a result, Copilot cannot open or process DKE-protected files for any user, even if they can open the file themselves in Office apps. Therefore, no user can use Microsoft 365 Copilot to summarize File1.

Box 2: will have messages decrypted automatically

Recipients from an external Microsoft 365 subscription can read emails protected by a Microsoft Exchange Online mail flow rule set to "Protect with OMEv2" (Microsoft Purview Message Encryption). External recipients will receive a wrapper email with instructions on how to access the encrypted message, either by signing in with their Microsoft account, Google account, Yahoo account, or by using a one-time passcode.
