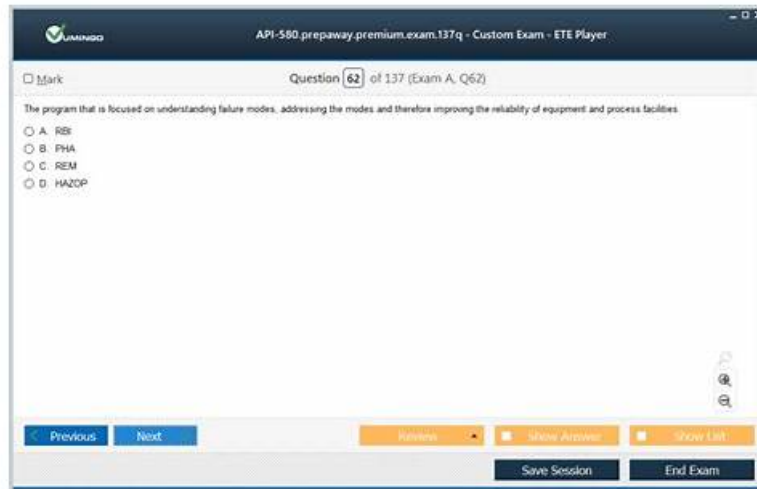

This statement confirms the value of performing RBI even in the absence of historical data, especially for forward-looking risk identification.
