

Creating DLP policies or label policies in Purview does not accelerate MRM processing.

* RPolicy2 # Adaptive scope (Scope2: SharePoint Online sites). # Not eligible for Preservation Lock.

* RPolicy3 # Static scope (Microsoft 365 groups). # Eligible for Preservation Lock.

Step 3 - Conclusion

Only RPolicy3 qualifies for Preservation Lock.
