This is triggered by a waterflow switch or heat detector, but the standard design uses the sprinkler head activation as the point of shutdown via heat detector.

Important: While the heat detector usually triggers the shunt trip, the sprinkler head activation is the condition being detected.

Correct answer: D. When a sprinkler head is activated
