The HR data is used by the insider risk management solution to generate risk indicators that can help you identify possible malicious activity or data theft by users inside your organization.

Step 1: From the Microsoft Entra admin center, create an app registration Task 1: Prepare a CSV file with your HR data The first step is to create a CSV file that contains the HR data that the connector imports to Microsoft 365. This data is used by the insider risk solution to generate potential risk indicators.

Task 2: Create an app in Microsoft Entra ID

The next step is to create and register a new app in Microsoft Entra ID. The app corresponds to the HR connector that you create in Task 3.

Creating this app allows Microsoft Entra ID to authenticate the HR connector when it runs and attempts to access your organization. This app will also be used to authenticate the script that you run in Task 4 to upload your HR data to the Microsoft cloud. During the creation of this Microsoft Entra app, be sure to save the following information. These values are used in Task 3 and Task 4.

Step 2: From the Microsoft Purview portal, add the data connector.

Task 3: Create the HR connector

The next step is to create an HR connector in the Microsoft Purview portal. After you run the script in Task 4, the HR connector that you create will ingest the HR data from the CSV file to your Microsoft 365 organization.

Step 3: Run a sample script to upload File1.csv

Task 4: Run the sample script to upload your HR data

The last step in setting up an HR connector is to run a sample script that will upload the HR data in the CSV file.
