"Where detectors are cleaned and maintained and where records of nuisance alarms and changes in detector locations are kept, the sensitivity testing interval shall be permitted to be extended to 5 years." Keeping a log of nuisance alarms helps assess the reliability of the detectors over time.

Correct answer: C. Records of nuisance alarms shall be maintained
