According to the APA's AICP Certification Exam Content Outline(2022), under "Areas of Practice," FBCs are noted for their emphasis on "regulating the physical form of development rather than land use," directly supporting the inclusion of building typologies as a distinguishing feature. Additionally, the Form-Based Codes Institute (referenced in APA study materials) defines FBCs as prioritizing "building types and their relationship to the street," which aligns with option D.
