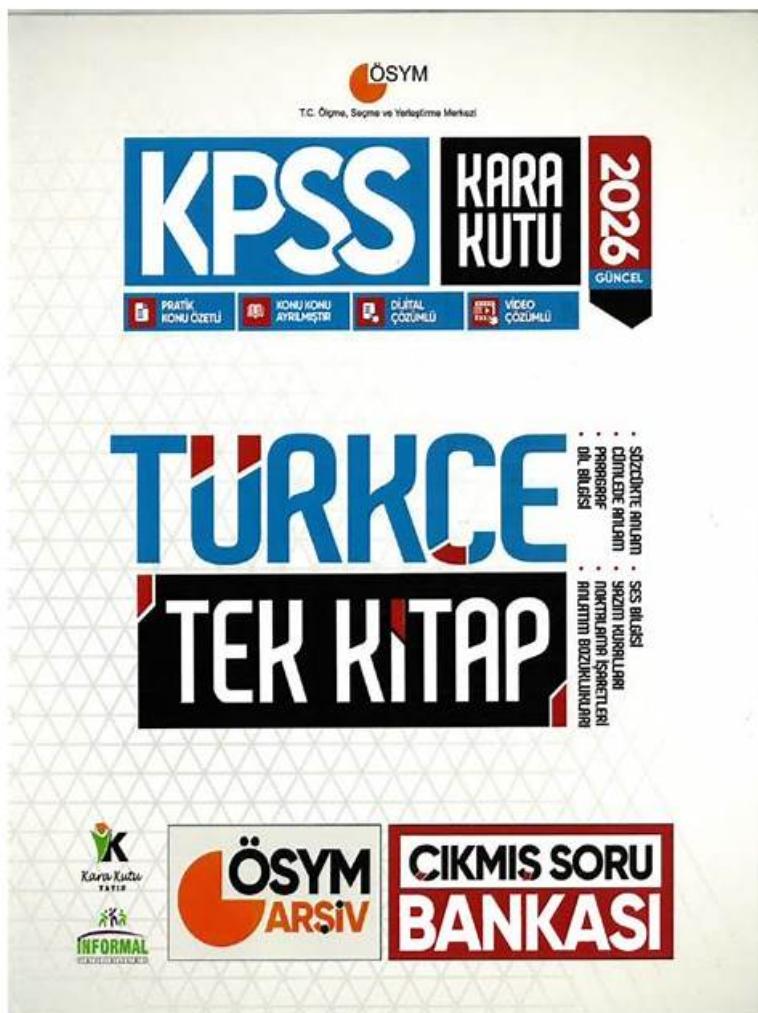

Ensure that only the contoso.com users can be invited as guests to the Microsoft Entra tenant: From the External collaboration settings, edit the Guest user access restrictions settings

* Modifying the Guest user access restrictions settings under External collaboration ensures that only users from specific domains,

like contoso.com, can be invited as guests to the Microsoft Entra tenant.
