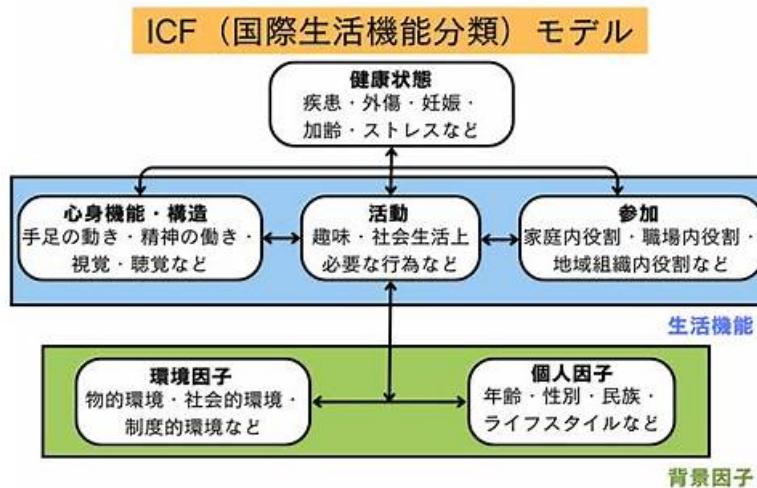

This section ensures that coaches adhere to ethical standards and legal requirements.
トピック 2	<ul style="list-style-type: none">Domain: Coaching Competencies, Strategies, and Techniques: This section measures the skills of Life Coaches in applying coaching competencies, strategies, and techniques. It includes knowledge of how to contract with clients, focusing on key elements of a coaching agreement. It also covers the ICF Core Competencies, goal setting, motivation, and a variety of coaching techniques, tools, and resources. This section ensures coaches are equipped to effectively support clients in achieving their goals.
トピック 3	<ul style="list-style-type: none">Domain: Definition and Boundaries of Coaching: This section evaluates the expertise of Coaching Consultants in understanding the definition of coaching and the coaching process. It includes differentiating coaching from related professions like therapy, counseling, mentoring, and consulting. Additionally, it covers knowledge of when and how to make appropriate referrals to mental health professionals and recognizing signs of mental health conditions that may hinder coaching progress. This section ensures coaches maintain clear boundaries and make informed decisions for client well-being.

質問 #69

When a coach maintains client confidentiality. Which ICF ethical standard are they honoring?

正解: C

The ICF Code of Ethics organizes standards under headings like "Responsibility to Clients" (Section 1).

Confidentiality is explicitly addressed in Section 4 ("Confidentiality/Privacy"), which falls under this responsibility, ensuring client trust and autonomy. Let's assess:

- * A. Responsibility to clients: Section 4.1 requires coaches to "maintain the strictest levels of confidentiality," directly tying this to client responsibility.
- * B. Responsibility to society: This (Section 5) focuses on broader impact, not confidentiality.
- * C. Responsibility to professionalism: This (Section 3) addresses conflicts of interest, not privacy.
- * D. Responsibility: This is incomplete; ICF uses specific categories, and confidentiality aligns with clients.

Option A is the ethical standard honored, per ICF's structure.

質問 #70

A potential client seeks expert advice and information about new markets on which they should focus their business. Which would most likely fit best for this client?

- A. Consulting
- B. Coaching
- C. Mentoring
- D. Coaching

正解: C

解説:

The ICF Definition of Coaching focuses on "partnering with clients in a thought-provoking and creative process" to maximize potential, not providing expert advice (ICF Coaching Boundaries). A client seeking

"expert advice and information" about markets requires a different approach. Let's analyze:

- * A. Consulting: Consulting involves delivering expertise and solutions, fitting the client's need for market-specific advice, distinct from coaching's non-directive nature (ICF Code of Ethics, Section 2.3).
- * B. Coaching: Coaching supports goal-setting and self-discovery, not delivering expert market insights (ICF Definition of Coaching).
- * C. Coaching: (Duplicate option) Same as B.
- * D. Mentoring: Mentoring shares experience and guidance, which is closer but less formal and expert-driven than consulting. Option A (consulting) best fits, as it aligns with the client's need for expertise, outside ICF coaching boundaries.

質問 # 71

At which point in the coaching process should the coach explain the rules around confidentiality?

- A. Before the coaching begins
- B. After assessment are completed
- C. Before scheduling a second session
- D. By the end of the first session

正解: A

解説:

The ICF Code of Ethics (Section 4.1) requires coaches to "explain and ensure that, prior to or at the initial meeting, my coaching client(s) understand the nature and limits of confidentiality." This must occur before coaching starts (Competency 3). Let's analyze:

- * A. Before the coaching begins: This aligns with Section 4.1 and Competency 3, ensuring clarity upfront.
- * B. By the end of the first session: This is too late; clients need to know limits before sharing (Section 4.2).
- * C. After assessments are completed: This delays critical disclosure, risking trust (Section 4).
- * D. Before scheduling a second session: This is after coaching begins, missing the ethical timing (Section 1.2).

Option A is the correct point, per ICF's ethical standards.

質問 # 72

If a company sponsors a coach to work with an employee, which party is responsible for ensuring the employee knows what situations would require the coach to breach confidentiality?

- A. The employee's supervisor
- B. The coach
- C. The employee
- D. The company attorneys

正解: B

解説:

The ICF Code of Ethics (Section 4.1) mandates that coaches "explain and ensure that, prior to or at the initial meeting, my coaching client(s) understand the nature and limits of confidentiality." In a sponsored arrangement, the coach retains this responsibility (Competency 3). Let's analyze:

- A . The employee: The client isn't responsible for defining confidentiality; this is the coach's duty (Section 4.2).
- B . The coach: The coach must clarify confidentiality, including sponsor-related exceptions, in the agreement (Section 1.2), making them responsible.
- C . The employee's supervisor: The supervisor may have a role in logistics, but not in explaining coaching ethics (Section 4).
- D . The company attorneys: Legal input may inform policy, but the coach directly communicates ethical standards to the client (Competency 3).

Option B reflects the coach's responsibility, per ICF standards.

質問 # 73

Nearing the end of a session, your client is still not quite sure what to do about a specific situation. You have the feeling that a similar experience that you have had in the past might be useful for the client. The worst response is:

- A. Share with the client that you have had a similar experience and enquire if the client would like to hear and see if anything in there may or may not be useful.
- B. Tell the client that you have had a similar experience and you know exactly what they should do.
- C. Ask the client if you can tell them a story, and then ask them to share what is relevant in the story.
- D. Share your story and list the possible options your client can try.

正解: B

解説:

Option A is the worst as it imposes the coach's solution, contradicting Competency 2.2 (partnership) and Competency 8.3 (client autonomy). It breaches Ethics Section 2.2 (avoiding bias) and the ICF Definition of Coaching by shifting to a directive stance. Option B and C are less intrusive but still assume relevance. Option D (best, see Question 9) respects the client. A most severely

undermines the coaching process by prioritizing the coach's agenda.
