

主題 2	<ul style="list-style-type: none">Employee Conduct and Reportable Events: This section of the exam measures the skills of Financial Compliance Specialists and covers regulatory expectations regarding employee conduct and disclosure requirements. Candidates must be familiar with Form U4 and Form U5, as well as reporting obligations for outside business activities and political contributions.
主題 3	<ul style="list-style-type: none">Overview of the Regulatory Framework: This section of the exam measures the skills of Compliance Officers and evaluates knowledge of self-regulatory organization (SRO) requirements, including registration and continuing education for associated persons. Candidates must understand the distinction between registered and non-registered individuals and the requirements for maintaining industry qualifications.

問題 #77

答案: D

Purchasing a put option allows the customer to sell the stock at a predetermined price (the strike price) if the share price declines. This strategy protects against downside risk while maintaining upside potential.

* C is correct because a put acts as insurance, locking in a minimum sale price.

* A is incorrect because selling a put exposes the investor to additional risk if the stock declines.

- * Bis incorrect because selling a call generates income but does not protect against downside risk.
- * Dis incorrect because purchasing a call is a bullish strategy unrelated to protecting existing positions.

問題 #78

How does an individual acquire restricted stock?

- A. By exercising publicly traded warrants
- B. By exercising an option for exchange-traded calls
- **C. By participating in an SEC Regulation D offering**
- D. By participating in an initial public offering (IPO)

答案： C

解題說明：

Restricted stock refers to securities acquired through private placements, such as those offered under Regulation D. These securities are not registered with the SEC and are subject to holding period restrictions before resale.

- * A is correct because Regulation D offerings involve private placements, resulting in restricted stock.
- * Bis incorrect because IPOs involve publicly traded shares, not restricted stock.
- * Cand Dare incorrect because restricted stock is not obtained through warrants or exchange-traded options.

問題 #79

Which of the following strategies is an investor most likely to employ using options contracts?

- A. Selling call options to set a definitive ceiling for potential losses
- **B. Buying put options to set a definitive floor for potential losses**
- C. Buying call options when the market shows downward momentum
- D. Buying put options when the market shows upward momentum

答案： B

解題說明：

Buying a put option gives the investor the right to sell a stock at a specific strike price, effectively setting a floor for potential losses if the stock price declines. This is a common risk-management strategy.

- * A is correct because buying puts limits downside risk while retaining the potential for upside gains.
- * Bis incorrect as buying puts is a bearish strategy, not one used during upward momentum.
- * Cis incorrect because selling call options does not hedge losses; it is a speculative or income-generating strategy.
- * Dis incorrect because buying calls is a bullish strategy, used during upward momentum, not downward.
