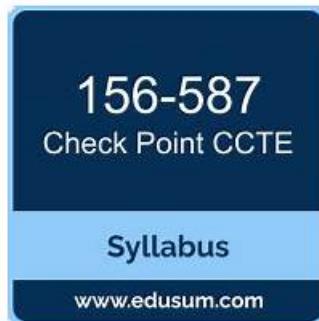

The STAT column does not show the Watch Dog name, the number of times the process was started, or the monitoring method of the Watch Dog.

The user space module handles the communication with the Check Point online web service and updates the kernel cache with the results.
