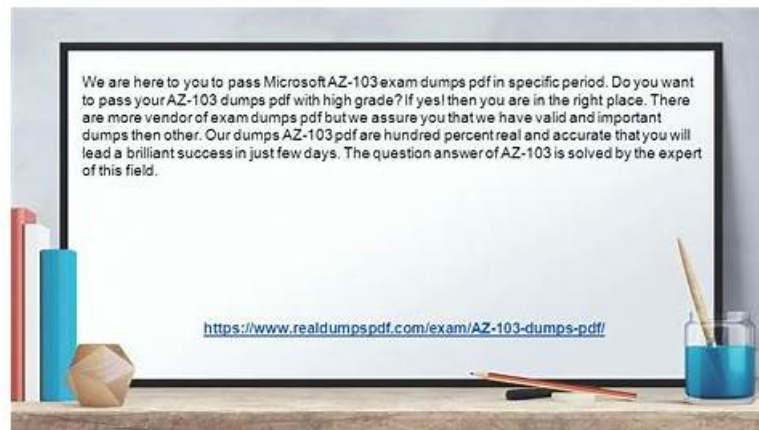

### NEW QUESTION # 11

An EDGE Auditor has been requested to provide auditing services to a development client. This particular client is well known as a hard negotiator and has offered the appointment on the basis of 50% payment for assessment and 50% upon successful EDGE certification of the building. Answer: A

Explanation:

EDGE Auditors must adhere to strict ethical guidelines to maintain independence and avoid conflicts of interest, particularly regarding payment structures that could influence their impartiality. Therefore, factories (heavy industry) (Option C) is the building type not covered by EDGE.
