How to use the keyword dictionary?

*Create a text file with one keyword per line.

*Upload it to Microsoft Purview under Data Classification > Sensitive Info Types.

*Use the dictionary in a DLP policy to identify and protect sensitive information.

Step 1 - Scenario

Microsoft 365 E5 subscription with 100 users and a Microsoft 365 group (Group1).

A sensitivity label (Label1) is published as the default label for Group1.

Label1 contains two sublabels: Sublabel1 and Sublabel2.

Requirement: Ensure Sublabel1 settings are applied by default to Group1.

Step 2 - Understanding label hierarchy

In Microsoft Purview Information Protection, a parent label (Label1) is a container.

Sublabels (Sublabel1, Sublabel2) inherit the parent name but represent distinct configurations (encryption, watermarking, access, etc.).

A parent label itself cannot have a sublabel's settings automatically applied unless policy configuration specifies which sublabel is used as the default publishing option.

Step 3 - Why "Modify the policy of Label1" is correct

To apply Sublabel1 by default, the published policy for Label1 must be modified so that Sublabel1 is the default label within the policy.

Simply reordering sublabels (Option A) does not change the default assignment.

Duplicating Sublabel1's settings into Label1 (Option B) defeats the purpose of having sublabels and adds redundancy.

Deleting the policy of Label1 and publishing Sublabel1 (Option D) would remove flexibility and is unnecessary.

Step 4 - Microsoft Reference

This requirement refers to recording and surfacing evidence of risky user behavior (e.g., copying sensitive files to USB, uploading to cloud storage, or exfiltrating data).

In Microsoft Purview Insider Risk Management, this is achieved through Forensic evidence, which allows capturing screenshots/clips of user activities on endpoints when a policy is triggered.

Integrates DLP capabilities with insider risk management

Microsoft introduced Adaptive Protection as part of Purview Insider Risk.

Adaptive Protection uses insider risk signals and DLP together, dynamically adjusting DLP controls (block, restrict, monitor) based on the user's risk level.

This integration reduces false positives and ensures risky users are monitored more strictly while low-risk users are less impacted.

Other options ruled out:

Adaptive scopes: Used for defining policy targeting groups dynamically, not capturing activities.

Classifiers/Trainable classifiers: Used for content classification, not exfiltration capture or DLP integration.

eDiscovery (Premium): For legal investigations, not insider risk + DLP integration.

Records management: Lifecycle retention, not related to insider risk.

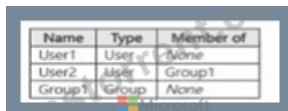

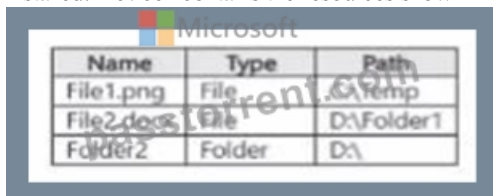

Step 1 - Label publishing and scope

The sensitivity label Label1 is published to User1 and Group1.

User1 # Directly included in label publishing.

User2 # Member of Group1, so also included indirectly.

This means both User1 and User2 are eligible to use Label1.

Step 2 - File vs Folder labeling with the Information Protection client The Microsoft Purview Information Protection (AIP unified labeling) client can apply labels to files such as .

docx, .png, .pdf, etc.

It cannot label folders directly. Labels are applied to items (files and emails), not folders.

Step 3 - Analyze each statement

User1 can apply Label1 to File1.png

File1.png is a file type supported by the Information Protection client.

User1 has Label1 published directly.

User1 can apply Label1 to Folder2

Sensitivity labels cannot be applied to folders in File Explorer.

User2 can apply Label1 to File2.docx

File2.docx is a supported file type (Word document).

User2 is a member of Group1, and Label1 is published to Group1.
