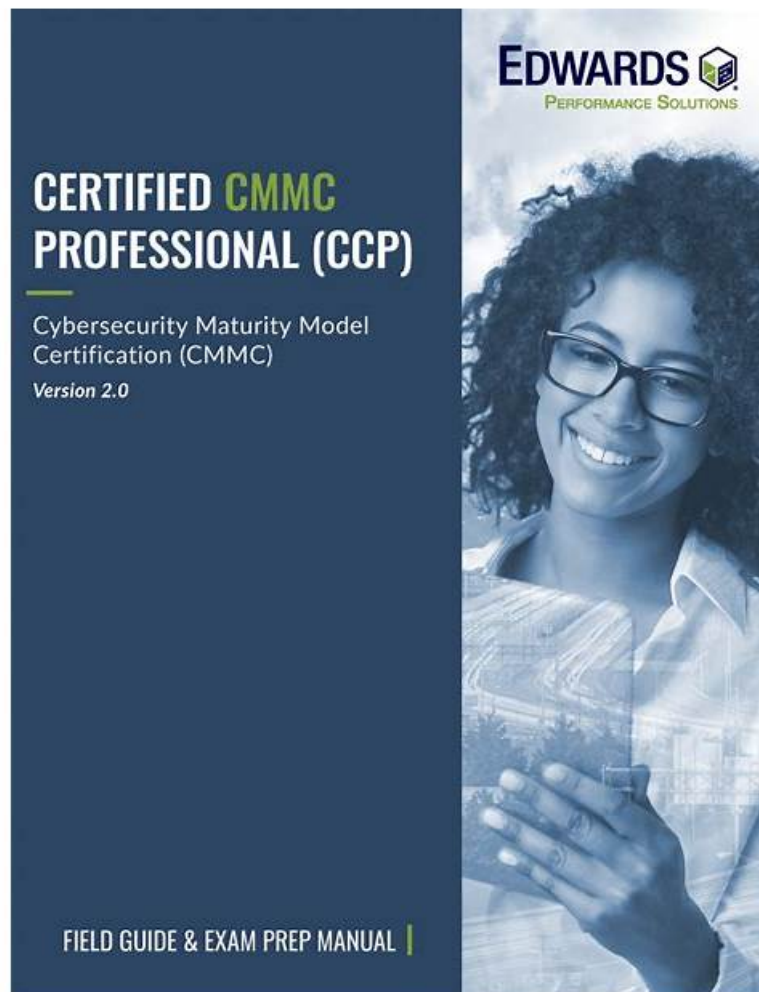

Key Requirement for a "MET" Rating For IA.L2-3.5.3 to be Met, the organization must:

- \* Require MFA for all privileged users (e.g., system administrators).

- \* Specialized assets (e.g., IoT, legacy systems) may have alternative security controls, but standard users and endpoints must still comply with MFA.

ISO 27001 (Option A) is an international standard for information security management but is not the basis for CMMC assessments. NIST SP 800-53A (Option B) provides security control assessments for federal systems, but CMMC assessments are based on NIST SP 800-171.

GAO Yellow Book (Option D) is a government auditing standard used for financial and performance audits, not cybersecurity assessments.

CMMC Assessment Process, as it is the official methodology all C3PAOs must follow when conducting CMMC assessments.
