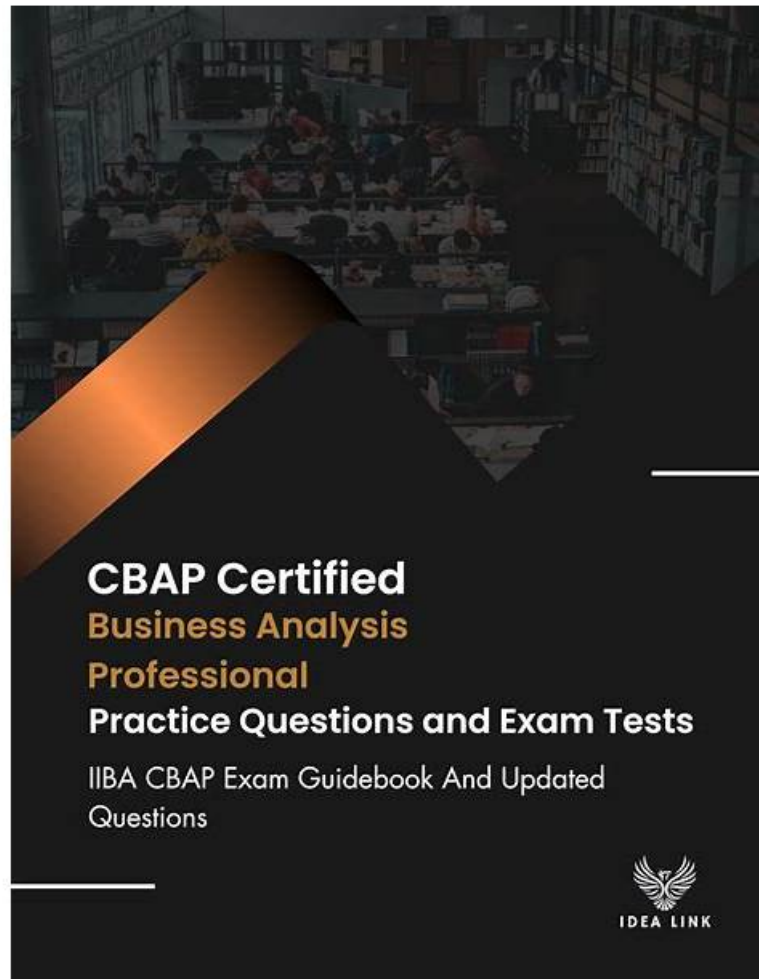

\$11,001 - \$14,000	–12%
\$9,001 - \$11,000	–10%
\$7,001 - \$9,000	–7.5%
\$5,001 - \$7,000	–5.5%
\$3,001 - \$5,000	–4%
\$2,001 - \$3,000	–3%
\$1001 - \$2,000	–2%

The percentage of the maximum possible discount available to the customer is adjusted based on time with the company:

Time with company (years)	Percentage of total discount
0	65%
1	73%
2	80%
3	85%
4	95%
5+	100%
